## CIRCUIT COURT CLERK ANNOUNCES <u>REVISED</u> SERVICE DELIVERY PLAN DURING COVID-19 PANDEMIC

Due to the COVID-19 public health crisis, the Circuit Court Clerk wishes to communicate information regarding the office's revised service delivery plan beginning Wednesday, March 25, 2020.

Pursuant to the attached court order entered March 24, 2020 regarding curtailment of Clerk's Office operations, the following modifications to service delivery will be in effect until further notice:

- Limited customer service hours (phones/appointment scheduling) 9:00-11:00 AM; 1:00-3:00 PM, Monday-Friday
  - Existing appointments for marriage licensing will be honored
  - o Marriage license applicants must apply online as public terminals are unavailable
  - For marriages taking place in Virginia, licenses can be issued by <u>any Circuit Court</u> <u>Clerk's Office in Virginia</u>. Service hours and requirements will vary by jurisdiction.
- Record Room is closed to the general public
  - Those with an urgent need for records access should call the Record Room at 804-717-6517
- Recording hours: 8:00 AM-3:30 PM Monday-Friday (eRecording, mail and drop box only)
  - Specific drop box for Deed Book recordations available at the Courts Building between 8:00 AM-3:30 PM Monday-Friday (follow instructions on designated box)
  - Documents may not be faxed, emailed or presented in office
- Drop box hours for matters other than Deed Book recordations: 8:00-4:00 Monday-Friday
- If paying by cash via drop box, please provide exact payment amount
- Appointments will be required for all in-person assistance

Clerk shall meet mission critical functions required by statute and by the Order

Declaring a Judicial Emergency, and any amendments thereto, and it is further:

**ORDERED** that the Circuit Court Clerk's Record Room is closed to the general public. The Clerk shall make accommodations to continue essential functions, including, but not limited to record research and document recording.

Electronic filings, pursuant to Va. Code Ann. §32.1-48.013:1 are encouraged.

The Clerk of the Chesterfield Circuit Court and the Clerk of the Colonial Heights Circuit Court, respectively, are directed to promulgate and to publish this order to the public and provide a copy to the Supreme Court.
