We request that members of the Bar allow order copies and other documents be emailed. Originals where appropriate, will be mailed or placed in your hold box in the records room.

Otherwise, please call the office, (276) 676-6224 / (276) 676-6226, or email me or any Deputy Clerk for information or an appointment for the duration of the pandemic declaration.

All estate qualifications will be handled by appointment only. Questions regarding estates will be taken by phone, fax or email.


CHP renewals can be submitted by mail, and the application is available on our county webpage. New applications must be dropped off at the security checkpoint and will be picked up immediately after dropoff for processing. Applications, instructions and addressed, stamped envelopes are available at the security checkpoint. Any questions regarding the CHP will be taken by phone, fax or email.

Marriage license issuance and copy inquiries will be handled by phone, fax or email. PLEASE call before appearing for a marriage license.

Attorneys, banks and title companies are encouraged to call the office and inquire about special offerings on remote access to land records, officer of the court remote access, efilings and erecording.
